The La Porte Jaycees Annual Arts & Crafts Festival has been the traditional kick off to the Jaycees 4<sup>th</sup> of July season in LaPorte for many years. The festival is followed annually by the LaPorte Fourth of July Parade and LaPorte Jaycees fireworks display at the LaPorte County Fairgrounds.

The festival is held in the parking lot off of State and Monroe Streets in La Porte, IN (behind Mucho Mas on Lincolnway). The Jaycees run the festival in conjunction with the LaPorte Farmer's Market, sponsored by the City of La Porte's Urban Enterprise Association.

## **FESTIVAL INFORMATION**

### **CRAFTER CHECK-IN**

1. All exhibitors must sign a liability waiver form.
2. Exhibitors **MUST** check in during official check-in times (6-7:30 a.m. 6/29/19) or lose exhibition space without refund.
3. Exhibitors must check in in person and attend the show in its entirety.
4. Exhibitors cannot sub-lease assigned booths or employ sales agents or representatives in lieu of checking in and attending the Festival personally.
5. Exhibitors not checked in by deadline (June 29 at 7:30 a.m. CST) will forfeit exhibition space and all fees.
6. Coffee, juice, and a snack will be provided to exhibitors at no additional charge while supplies last.

### **PRODUCT**

1. Any sales items not listed in the application may be removed from the show at the Jaycees discretion.
2. All articles and displays must be in good taste with no reference to race, ethnic, gender, sexual, or religious prejudice. No obscene items will be allowed.

### **BOOTH DISPLAY & SET-UP**

1. Booth space is limited to the size in which you paid.
2. Single Spaces are 10' wide x 10' deep. Double spaces are 10' wide x 20' deep. All spaces are on pavement.
3. Exhibitors must furnish their own display tables, skirting, chairs, and extension cords.
4. Signs, tents, canopies, or any other part or display may not extend over or into walkways.
5. Requests for specific placement will be considered but cannot be guaranteed.

### **FESTIVAL RULES**

1. Gas powered generators are strictly prohibited.
2. Electricity is available for an additional fee and must be requested on the application. Exhibitors must furnish their own extension cords.
3. The LaPorte Jaycees will not be responsible in any way for loss or damage to participant's property. Exhibitors are responsible for their own personal and property liability.
4. Vehicles are **NOT** allowed in the festival area during show hours.

**ANY VIOLATION OF THE RULES AND REGULATIONS STATED HEREIN AT ANY TIME MAY RESULT IN THE LOSS OF EXHIBIT SPACE FOR THE DURATION OF THE SHOW WITHOUT REFUND AND THE EXHIBITOR MAY BE EXCLUDED FROM FUTURE JAYCEES FESTIVALS.**

### **APPLICATION**

1. A signed application constitutes a contract to follow all rules and regulations. It is a contract to participate, personally, if accepted.
2. Please note that space is limited and spots are reserved on a first come, first serve basis.
3. Applications must be postmarked on or before June 15, 2019 to lock in the \$35 per single space fee.

4. Applications postmarked after June 16, 2019 are required to pay \$50 per single space.

5. **Complete and sign official application form.**

6. Enclose a cashier's check, money order or personal check made payable to: LaPorte Jaycees. A \$35 service charge will be issued for returned checks. PayPal (laportejaycees@gmail.com) and cash payments are also acceptable. All fees will be processed and deposited as received. **THIS DOES NOT GUARANTEE ACCEPTANCE.**

7. Any withdrawal from the Festival must be sent via email or received in writing (signed and dated by the applicant and bearing an official U.S. Postmark) on or before June 22, 2019 to be eligible for a refund on your space rental fee.

Cancellation by applicant after June 22, 2019, will result in a loss of all deposits.

8. Refunds for non-accepted applicants will be credited back after the non-acceptance letters are mailed, depending on type of payment received.
